Memorandum of Understanding

This Memorandum of Understanding (MOU) sets for the terms and understanding between the **Middle East International Dermatology and Aesthetic Medicine (MEIDAM) Association** and the **National Alliance of Dermatologists and Cosmetologists (NADC)** to support each other's scientific and professional endeavors.

Purpose

This MOU aims to increase collaborative efforts between leaders and experts in dermatology and aesthetic medicine to support scientific development, boost engagement of seniors and juniors in the field, and eventually enhance patient care.

The above goals will be accomplished by undertaking the following activities:

- The two parties to facilitate and/or participate in scientific meetings held by the other party.
- **MEIDAM** to grant automatic unconditional membership for all member of the **NADC**.

- **MEIDAM** to grant a 50% discount on the registration fees of its annual conference to all members of the **NADC**.
- **MEIDAM** to grant the president of the **NADC** a position as part of its governing executive committee.
- **MEIDAM** to grant the president of the **NADC** a free registration at its annual conference alongside a compensation for the flight and accommodation for the period of the conference.
- **MEIDAM** to assign a session hosted and coordinated by the **NADC** at their annual meeting.
- **MEIDAM** to grant the **NADC** members access to the recordings of its annual meetings.
- The **NADC** to grant conditional membership to **MEIDAM** members as they see fit.
- The two parties to facilitate the attendance and presence of the other party at its annual meeting.
- The two parties to have recurrent meetings to explore potential collaborative projects.
- The two parties to support joint advocacy efforts aiming to develop dermatology and aesthetic medicine in the Middle East and worldwide.
- The two parties to explore volunteering opportunities and research grants that their members can jointly partake.
